



## Tutorial de preenchimento do Formulário DS-160 para emissão de Visto Americano



O presente **TUTORIAL** tem por objetivo orientar o militar e seu dependente no preenchimento do Formulário DS-160 para a emissão de Visto Americano.

As orientações abaixo são direcionadas para o cadastramento de **dados do viajante e da missão no exterior de forma generalizada**, portanto, no momento do preenchimento do referido formulário o usuário deve atentar para as particularidades de sua situação cadastral, dos dados de sua atividade nos EUA, os locais a serem visitados e outras informações pertinentes.

Existem diversos tipos de visto americano e cada um deles possui uma finalidade específica. Certifique-se de informar o tipo de visto de entrada adequado de acordo com sua missão. No e-mail de orientação para solicitação de vistos esta informação já vem disponibilizada. Em caso de dúvidas, entre em contato com a Assessoria de Pessoal do Gabinete do Comandante do Exército.




